

KNOW ALL MEN BY THESE PRESENTS, That... ROD E. TRAVIS

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by JOSEPH R. DALTON and FRANCES MARY DALTON, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 13, Block 12, EIGHT ADDITION TO SUNSET VILLAGE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Assessment power of Enterprise Irrigation District and South Suburban Sanitary District.
2. Reservations and easements as contained in plat dedication.
3. Covenants, conditions and restrictions, including the terms and provisions thereof imposed by instrument recorded March 25, 1975 in Volume M75, page 3318, Microfilm Records of Klamath County, Oregon.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
