KNOW ALL MEN BY THESE PRESENTS, That CLIFFORD J. EMMICH, and WINIFRED L. EMMICH, h/w, 1931 El Arbolita Dr., Glendale, California, 91208, hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by FRED W. KOEHLER, JR., and CHARLOTTE KOEHLER, h/w, 1362 Lance Drive, Tustin, California, 92680,

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

TO: SHIP 35 South, Range 10 East, W.M. Section 20: North 1/2 of South West 1/4.

This conveyance is made subject to: reservations and restrictions of record, easements and rights of way of record, and those apparent on the land, and to a 60' wide easement for Joint user roadway and all other roadway purposes along Westerly and Northerly Boundary and Grantor reserves for Grantee and his successors the same easement along Westerly Boundary of Section 20 and Section 29 laying North of the Sprague River Highway.

TO HAVE AND TO HOLD the above described and granted premises unto the said grantees, their assigns and the heirs of such survivor, forever; provided that the grantees herein do not take the title in common but with the right of survivorship, that is, that the fee shall vest absolutely in the survivor of the grantees.

And the grantor above named hereby covenants to and with the above named grantees, their heirs and assigns, that grantor is lawfully seized in fee simple of the above granted premises, that the said premises are free from all encumbrances

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 9,375.00
