All of that portion of the W $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 35, Twp. 33 S.R. 7 E.W.M., Klamath County, Oregon, lying East of the Medial Line in Williamson River.
