## QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That William W. Dewing

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto William W. Dewing and Dorothy M. Dewing, husband and wife

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of Klamath

State of Oregon, described as follows, to-wit: All that real property situated in Lot 43 and vacated Logan Street, Gloverdale" subdivision, in Section 2, 39S, R9EWM, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the North line of said Lot 43 said point being S89°13'W 73.9 feet from the NE corner of said Lot 43 and also being the SE corner of Lot 16 "Schieles Tracts"; thence S89°13'W a distance of 17.1 feet to the NW corner of said Lot 43; thence continuing S89 13'W a distance of 30.0 feet to the center line of vacated Logan Street a distance of 30.0 feet; thence N89 13'E a distance of 47.1 feet; thence N 00°09'E parallel to the East line of said Lot 43 a distance of 30.0 feet to the point of beginning.
