WHEREAS, WEYERHAEUSER COMPANY and the UNITED STATES OF AMERICA entered into a Supplemental Agreement dated September 14, 1970, filed for record in Lake County, Oregon, on November 16, 1970, recorded in book 156 at page 565 of Record of Deeds, and on June 1, 1971, recorded in book 158 at page 90 of Record of Deeds; and filed for record in Klamath County, Oregon, on October 20, 1970, in volume M70 of Deeds at page 3949, and recorded on June 8, 1971, in volume M71 of Deeds at page 5542, which Supplemental Agreement was supplemental to an original easement for a drift fence dated April 8, 1964, and recorded in the Deed Records of Klamath County, Oregon, in volume 352 at page 410, and Lake County, Oregon in book 139 at page 331; and

WHEREAS, there is no further need for said Supplemental Agreement.

NOW, THEREFORE, the parties hereto agree that said Supplemental Agreement is hereby terminated. It is understood that this termination agreement shall affect only the Supplemental Agreement dated September 14, 1970, and any and all other supplemental agreements to the April 8, 1964, drift fence easement and the April 8, 1964, drift fence easement itself shall remain in full force and shall not be affected hereby.

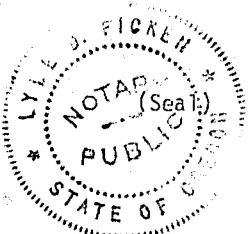

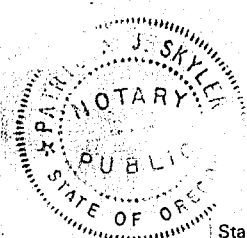
