The Mortgagor does hereby covenant and agree to and with the Mortgagee, its successors and assigns:

That Mortgagor will cay, when due, the indebtedness 1 hereby secured, with interest as prescribed by said note, and will pay, when due, all other sums secured hereby, and all taxes, liens and utility charges upon said promises, or for services furnished thereto.
