KNOW ALL MEN BY THESE PRESENTS, That PHILLIP DODDRIDGE, as attorney in fact for LAWRENCE J. JOHNSON, a single man, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by JERRY E. SCOTT and CATHERINE E. SCOTT, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A parcel of land situated in the Easterly portion of Lot 3 and 4 of Block 52 of BUENA VISTA ADDITION TO THE CITY OF KLAMATH FALLS, OREGON, being more particularly described as follows:

Beginning at a bolt marking the Northeast corner of said Lot 4; thence South 18° 17' 10" West along the Easterly line of said Block 52, 98.00 feet to a 1/2 inch iron pin; thence North 71° 42' 50" West parallel to but 12.00 feet Northerly of the Southerly line of said Lot 3, 79.73 feet to a 1/2 inch iron pin; thence North 18° 17' 10" East, 104.56 feet to a 1/2 inch iron pin on the Northerly line of said Lot 4; thence South 67° 00' 30" East along said Northerly line of Lot 4, 80.00 feet to the point of beginning.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances, reservations, restrictions, easements and rights of way of record and those apparent on the land, if any,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
