KNOW ALL MEN BY THESE PRESENTS, That Wayne N. Horton

Horton, husband and wife, as tenants by the entirety, each as to an undivided one-half interest, hereinafter called grantee, and unto grantees heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

SE 1/4 SW 1/4 and SW 1/4 SE 1/4 of Section 22, Township 39 South, Range 9 E.W.M., SAVING AND EXCEPTING THEREFROM the right of way of the Modoc Northern Railway and the F31 Lateral. ALSO SAVING AND EXCEPTING all that portion of the SW 1/4 SE 1/4 lying East of the Railroad right of way. ALSO SAVING AND EXCEPTING beginning at the intersection of the Westerly line of the Central Pacific Railway Co. right of way and the section line common to Sections 22 and 27, Township 39 S., Range 9 E.W.M. in Klamath County, Oregon, being 3444 feet, more or less, East of the section corner common to Sections 21, 22, 27 and 28, Township 39 S., Range 9 E.W.M.; thence North 33°16' West 1636 feet, more or less, and parallel to the Central Pacific Railway Company right of way; thence North 1636 feet, more or less, and parallel to the right of way of the said Central Pacific Railway to the section line common to said Sections 22 and 27; thence Easterly along the section line common to said Sections 22 and 27, 98.02 feet, more or less, to the point of beginning, containing 3.00 acres, more or less.
