To Have and to Hold the above described granted premises unto the said grantee and grantee's successors, heirs and assigns forever.

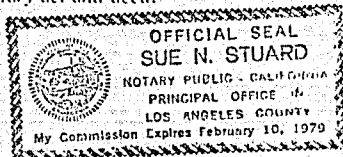
