When Buyer pays and performs this contract in full, Seller shall give to Buyer, or Buyer's heirs or assignd, a good and sufficient warranty deed conveying good and merchantable title in fee simple, free and clear of encumbrances decepting liens and encumbrances suffered or permitted by the Buyer or Buyer's heirs or assigns and subject to restrictions in the patent from the United States Government and the State of Oregon, restrictions in the dedication of the plat, the regulations and rutes of Klamath County, and restrictions of record in the official files of the County.

Seller's Remedies:

Time is of the essence of this contract and Buyer agrees to promptly make all payments when due and to fully and promptly perform all other obligations of this contract. In the event of detault by the Buyer upon any of the terms and acconditions contained herein and after 30 days written notice of default by Seller:

(1) Seller may declare this contract terminated and at an end and upon such termination, all of Buyer's right distendinterest in and to the described property shall immediately case.
