

WARRANTY DEED—TENANTS BY ENTIRETY

KNOW ALL MEN BY THESE PRESENTS, That Helen M. Brown

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by Waldo D. Lasley and Lila Lee Lasley

husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath

State of Oregon, described as follows, to-wit: Lot 6 in Block 105 of Buena Vista Addition to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, saving and excepting therefrom that portion conveyed to State of Oregon, by and through its State Highway Commission, by deed recorded November 4, 1955, Deed Vol. 279, page 45, and recorded March 13, 1959, Deed Vol. 310, page 477, records of Klamath County, Oregon.

Subject, however, to the following:

1. Access restrictions, including the terms and provisions thereof, contained in deeds from LeRoy Brown and Bessie L. Brown, husband and wife, to State of Oregon, by and through its State Highway Commission, recorded November 4, 1955, Deed Vol. 279, page 45, and recorded March 13, 1959, Deed Vol. 310 page 477, records of Klamath County, Oregon.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as noted of record as of the date of this deed and those apparent upon the land, if any, as of the date of this deed,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 23,000.00
