REMOVAL ORDER NO. 77-12

On the 27th day of February, 1935 on recommendation of the Oregon State Board of Forestry, the State Tax Commission, now the Department of Revenue, entered an order classifying certain lands in Klamath County, Oregon, as reforestation lands; and

These lands were transferred to the City of Klamath Falls, Oregon, and pursuant to ORS 321.291 (4-C) must be removed from classification, it is

Therefore ordered, that the described land in Klamath County, Oregon, is hereby removed from Reforestation Classification Order No. 36, and is subject to assessment for ad valorem property taxation.
