Mr. Ray Bissell of 1005 Newcastle and Mr. Robert H. Smith III of 935 Newcastle, Klamath Falls, Oregon, are hereby authorized to encroach upon the Manzanita Street right-of-way as described below:

> That portion of Manzanita Street right-of-way adjacent to and bound by Lot 6, Block 40 and Lot 1, Block 41, Hillside Addition to the City of Klamath Falls, Oregon, as shown on the attached map, marked Exhibit "A".

Said encroachment shall be granted under the following provisions:

- 1. Said permission shall carry a non-refundable fee of twenty-five dollars (\$25.00).
- 2. Said permission shall be revocable upon written notice by the City of Klamath Falls within a reasonable time limit and it shall be non-exclusive.
- Mr: Ray Bissell and Mr. Robert H. Smith III or future owners of property at 3. 1005 Newcastle Avenue and 935 Newcastle Avenue shall hold the City of Klamath Falls and its authorized representatives harmless from claims for damage to personal property placed within the encroachment area which occurs as a result of the City's subsequent use at said encroachment area.
- 4. Mr. Ray Bissell and Mr. Robert H. Smith III or future owners of property at 1005 Newcastle Avenue and 935 Newcastle Avenue shall be responsible for damages to any person injured who injury is caused by said encroachment. The owner(s), or future owner(s), shall take all reasonable precautions to insure the safety of the public upon the affected portion of the Manzanita Street right-of-way.

5. The City shall file the encroachment permit with the County Clerk.
