HOLMES and MILDRED HOLMES, husband and wife, hereinafter called Assignors, do hereby sell, transfer, set over and assign to STAN S. SEVRUK and MARIAN L. SEVRUK, husband and wife, hereinafter called Assignees, all right, title and interest in a certain piece of real proeprty, and all right, title and interest in a certain contract dealing with said real property, entered into on the 1st day of October, 1970, by and between Edgar J. Blodgett and Evangeline F. Blodgett, husband and wife, as Sellers, and Robert K. Holmes and Mildred Holmes, husband and wife, as Buyers. The Assignors are hereby selling, transferring and assigning to the Assignees all of their right, title and interest therein of the following described property, situate in the County of Klamath, State of Oregon, to-wit:

A tract of land situated in the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 29, Township 39 South, Range 9 East of the Willamette Meridian.

The West 644 feet of the East 1304 feet except therefrom the East 350 feet of the South 652 feet; also except therefrom any portion lying within the right of way of Del Fatti Road; further excepting any portion lying within the C-4r Lateral.  
SUBJECT TO: An easement 30 feet in width, for ingress and egress to adjoining property, over the East 30 feet of the hereinabove described property.

It is agreed, for the consideration above recited, between Assignors and Assignees, the Assignees assume and agree to pay the balance of said contract as determined by the records of Blodgett Realty, Klamath Falls, Oregon, and to in all ways save the Assignors harmless from any obligation thereon.
