THIS MATTER having come on for hearing upon the application of Jerry Ward for Robert Stewart for a change of Zone No. 76-8, for a change from RA (Residential Agricultural) to MHP (Mobile Home Park) on real property described as a parcel of land approximately six (6) acres in size gen? erally located about 986 feet north of Shasta Way bordered on the west by Homedale Road and more particularly described as the west 790 feet of Tract 70 of Fairacres Subdivision No. 1, Klamath County, Oregon. A public hearing having been heard by the Klamath County Planning Commission on July 27, 1976, where the applicant requested a continuance of the hearing to enable the applicant to further explain his proposal to the Shasta Suburban Area Committee. The hearing was then continued to September 14, 1976, and the applicant did not appear at that hearing. Because of a lack of testimony in favor of the Zone Change, the Planning Commission recommended to the Klamath County Board of Commissioners that they disapprove the Zone Change. The Klamath County Board of Commis-sioners held a public hearing on October 18, 1976, and referred the application back to the Planning Commission for a new hearing. A public hearing having been heard by the Klamath County Planning Commission on January 25, 1977, and again the applicant did not appear at the hearing. Based on the fact that the applicant was given adequate notice of the date and time of the hearing and that the applicant failed to produce any evidence in favor of the Zone Change, the Klamath County Planning Commission recommended to the Board of County Commissoners that they disapprove Zone Change 76-8, Jerry Ward for Robert Stewart. Following action by the Planning Commission, a public hearing before the Board of County Commissioners was regularly held on March 7, 1977, where the Board of County Commissioners reviewed the record on the application for Zone Change 76-8, Jerry Ward for Robert Stewart, and made a motion to disapprove, Zone Change 76-8, Jerry Ward for Robert Stewart based on the fact that the applicant failed to produce any evidence in favor of the Zone Change.
