THE UNITED STATES OF AMERICA, acting by and through the Regional Director, Mid-Pacific Region for the Secretary of the Interior, in pursuance of the Act of Congress approved June 17, 1902 (32 Stat. 388) and acts amendatory thereof or supplementary thereto and particularly to the Act of Congress approved June 30, 1949 (63 Stat. 377), as amended and supplemented and orders, circulars and delegations made and issued thereunder, does in consideration of FIFTY DOLLARS (\$50.00) to it in hand paid, receipt of which is duly acknowledged hereby quitclaim to Ernest W. Smith and Beverly Ann Smith, husband and wife, without warranty of title all of its right, title and interest in and to all that certain real property situated in the County of Klamath, State of Oregon, more particularly described as follows:

A parcel of land in Section Thirty-six (36), Township Thirty-nine (39) South, Range Seven (7) East, W.M., being a portion of that 60-foot-wide tract of land along the easterly boundary of said Section 36, as described in the conveyance from Thomas McCormick, et ux., to the United States of America, recorded on August 9, 1909, in Book 27 of Official Records at page 294, Klamath County Records, State of Oregon; also a portion of that tract of land as described in the Deed from Kenneth E. 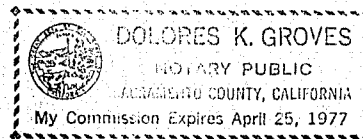
