3. Basin agrees to pay Stukel the sum of \$27,124.00 together with interest thereon at the rate of 9 % from the date of completion of the project, until said principal and interest are paid in full as follows:

b. The principal sum and interest shall be due and payable within one year from the date of completion of the project.

4. This contract consists of this Agreement and the following documents which are attached and by this reference made a part hereof:

a. Plans and specifications for paving.

b. Drawing of the area concerned.

5. This Agreement constitutes the entire Agreement between Basin and Stukel and may be altered, amended or repealed only by a duly executed written instrument signed by Basin and Stukel.
