KNOW ALL MEN BY THESE PRESENTS, That..... BASIN BUILDING, INC.

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by RUTH C. SCOPELITE, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

Lot 11, Block 8, THIRD ADDITION TO MOYINA, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Regulations of South Suburbans Sanitary District.
2. An Easement created by instrument recorded April 5, 1940 in Volume 128, page 267.
3. An Easement and right of way created by instrument recorded June 8, 1956 in Volume 284, page 22.
4. An Easement, covering water mains running to well site described in Deed Volume 285, page 257.
5. A 20 foot building setback from streets as shown on dedicated plat.
6. Public utility easement along rear 16 feet of lot as shown on dedicated plat.
7. Restrictions and easements contained in plat dedication.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
