KNOW ALL MEN BY THESE PRESENTS, that the City of Klamath Falls, a municipal corporation, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Robert Garrett, a married man, as his individual property, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the City of Klamath Falls, County of Klamath, State of Oregon, described as follows, to-wit:

Lots 1, 2, 3, 4, 5 & 6, Block 1; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 & 12, Block 7; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 & 12, Block 12; Lots 5, 6, 7, & 8, Block 19; Lots 1, 2, 3 & 4, Block 20; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9 & 10, Block 21; all in the Irvington Heights Addition to the City of Klamath Falls.
