

KNOW ALL MEN BY THESE PRESENTS, That JACK E. MILNER and JULIA A. MILNER, husband and wife hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by AARON ABTS and LOIS ABTS, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Lot 4 in Block 4 of TRACT NO. 1007, WINCHESTER, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

6. Mortgage, including the terms and provisions thereof, recorded October 18, 1976 in Volume M76, page 16477, Microfilm Records of Klamath County, Oregon, in favor of State of Oregon, Represented and acting by the Director of Veterans' Affairs, which Mortgage, the Grantees herein assume and agree to pay according to the terms and conditions as contained therein.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
