Done by the order of the grantor's board of directors with it's corporate seal affixed, this 2 day of June, 19 77.

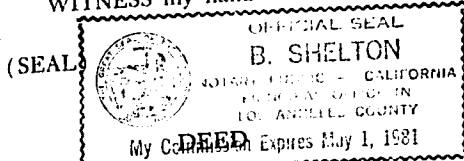
