Interest shall be computed on the average monthly balance in the account and shall be paid quarterly to the grantor by crediting to the secrow account the amount of the interest due.

While the grantor is to pay any and all taxes, assessments and other charges levie or assessed against said property, or any part thereof, before the same begin to be interest and also to pay premiums on all insurance policies upon said property, such pay ments are to be made through the beneficiary, as aforesaid.
