In construing this contract, it is understood that the seller or the buyer may be more than one person; that il the context so requires, the singu-onoun shall be taken to mean and include the plural, the meaculine, the feminine and the neuter, and that generally all grammatical changes shall de, assumed and implied to make the provisions hereol apply equally to corporations and to individuals.
