The grantor covenants and agrees to pay said note according to the terms thereof and, when due, all taxts, assessments and other charges levied against and property; to keep said property free from all encumbrances having precedence over this trust deed; to complete all buildings in course of construction or hereafter constructed on said premises within six months from the date hereof or the date construction is hereafter commenced; to repair and restore promptly and in good workmanlike manner any building or improvement or add property which may be damaged or destroyed and pay, when due, all times during construction; to replace any work or materials unsatisfactory to beneficiary within fifteen days after written notice from beneficiary of subcentificary of inspect said property at all times during construction; to replace any work or materials unsatisfactory to beneficiary within fifteen days after written notice from beneficiary or subcentificary of improvements now or hereafter erected upon said property in good repair and to commit or suffer ow waste of said premises; to keep all buildings, property and improvements now or hereafter erected on said promises continuously insured against loss by fire or such other hazards as the beneficiary may for time require, in a sum not less than the original principal sum of the note or obligation secured by this trust deed, in a company or companies acceptable to the beneficiary, and to deliver the original policy of insurance in correct form and with reminim paid, to the principal place of business of the beneficiary may in the second provided principal sum of the beneficiary and the fifteen days prior to the effective date of any such policy of insurance in contract of the property and insurance for the beneficiary and the first contract of the property of insurance for the benefic of the beneficiary which insurance for the benefic of the penef

That for the purpose of providing regularly for the prompt payment of all taxes, assessments, and governmental charges levied or assessed against the above described property and insurance premium while the indebtedness secured hereby is in access of 80% of the lesser of the original purchase price paid by the grantor at the time the loan was made or the beneficiary's original appraisal value of the property at the time the loan was made, grantor will pay to the beneficiary in addition to the monthly payments of principal and interest payable under the terms of the note or obligation secured hereby on the date installments on principal and interest are payable an amount equal to 1/12 of the taxes, assessments, and other charges due and payable with respect to said property within each succeeding 12 months and also 1/38 of the insurance premium payable with respect to said property within each succeeding three years while this Trust Deed is effect as estimated and directed by the beneficiary. Beneficiary shall pay to the grantor interest on said amounts at a rate not less than the highest rate authorized to be paid by banks on their open passbook accounts minus 3/4 of 1%. If such rate is less than 4% the tate of interest paid shall be 4% interest shall be computed on the average monthly balance in the account and shall be paid quarterly to the grantor by crediting to the escrow account the amount of the interest due.

While the grantor is to pay any and all taxes, assessments and other charges leded assessed against said property, or any part thereof, before the same begin to bear creat and also to pay premiums on all insurance policies upon said property, such paymins are to be made through the beneficiary, as aforesaid. The grantor hereby suthorizer beneficiary to pay any and all taxes, assessments and other charges level or impost insist said property in the amounts as shown by the statements thereof furnished by the lector of such taxes, assessments or other charges, and to pay the insurance premiums the amounts shown on the statements submitted by the insurance carriers or heir repentatives and to withdraw the sums which may be required from the reserve account, any, established for that purpose. The grantor agrees in no event to hold the beneficiary possibile for failure to have any insurance wiltien or for any loss or damage growing of a defect in any insurance policy, and the beneficiary hereby is authorized, in the not of any loss, to compromite and settle with any insurance company and to apply any h insurance receipts upon the obligations accured by this trust deed, in computing the ount of the indebtedness for payment and satisfaction in full or upon sale or other

acquisition of the property by the beneficiary after default, any balance remaining in the reserve account shall be credited to the indebtedness. If any authorized reserve account for taxes, assessments, insurance premiums and other charges is not sufficient at any time for the payment of such charges as they become due, the grantor shall pay the deficit to the beneficiary upon demand, and if not paid within ten days after such demand, the beneficiary may at its option add the amount of such deficit to the principal of the obligation secured hereby.

Should the grantor fail to keep any of the foregoing covenants, then the beneficiary may at its option carry out the same, and all its expenditures therefor shall draw interest at the rate specified in the note, shall be repayable by the grantor on demand and shall be secured by the lien of this trust deed. In this connection, the beneficiary shall have the right in its discretion to complete any improvements made on said premises and also to make such repairs to said property as in its sole discretion it may deem necessary or advisable.

The grantor further agrees to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting said property; to pay all costs, fees and expenses of this trust, including the cost of title search, as well as the other costs and expenses of the trustee incurred in connection with or in enforcing this obligation, and trustee's and attorney's fees actually incurred; to appear in and defend any action or proceeding purporting to affect the security hereof or the rights or powers of the beneficiary or trustee; and to pay all costs and expenses, including cost of evidence of title and attorney's fees he reasonable sum to be fixed by the court, in any such action or proceeding twhich the beneficiary or trustee may appear and in any suit brought by beneficiary to foreclose this deed, and all said sums shall be secured by this trust deed.

Upon any default by the grantor hereunder, the beneficiary may at any time without notice, either in person, by agent or by a receiver to be appointed by a court, and without regard to the adequacy of any security for the indebtedness hereby secured, enter upon and take possession of eail property, or any part thereof, in its own name sue for or otherspise collect the rents, issues and profits, including those past due and unpaid, and apply the same, less costs and expenses of operation and collection, including reasonable attorney's fees, upon any indebtedness secured hereby, and in such order as the beneficiary may determine.
