Beneficiary shall pay to the grantor interest on and amounts at a rate not less than the highest rate authorized to be paid by banks on their open passbook accounts minus 3/4 of 1%. If such rate is less than 4%, the rate of interest paid shall be 4%. Interest shall be computed on the asterage monthly balance in the account and shall be paid quarterly to the grantor by crediting to the excrew account the amount of the interest due.

While the grantor is to pay any and all taxes, assessments and other charges lederly or assessed against said property, or any part thereof, before the same began to bear interest and also to pay premiums on all insurance policies upon said property, such payments are to be made through the beneficiary, as aforesaid. The grantor hereby authorizes the beneficiary to pay any and all taxes, assessments and other charges lesied or imposed against said property in the amounts as shown by the statements intereof turnished by eagliest of such taxes, assessments or other charges, and to pay the insurance premiume in the amounts shown on the statements submitted by the insurance carriers or their representatives and to withdraw the sums which may be required from the reserve account if any, established for that purpose. The grantor agrees in no event to hold the beneficiary responsible for failure to have any insurance written or for any loss or damage growing out of a defect in any insurance policy, and the beneficiary hereby is authorized, in the centre of any loss, to compromise and settle with any insurance company and to apply sin event of any loss, to compromise and settle with any insurance company and to apply sus such insurance receibts upon the obligations accured by this trust deed. In computing the amount of the indebtedness for payment and satisfaction in full or upon sale or other

acquisition of the property by the beneficiary after default, any balance remaining in the reserve account shall be credited to the indebtedness. If any authorized reserve account for taxes, assessments, insurance premiums and other charges is not sufficient at any time for the payment of such charges as they become due, the grantor shall pay the deficit to the beneficiary upon demand, and if not paid within ten days after such demand, the beneficiary may at its option add the amount of such deficit to the principal of the obligation secured hereby.

Should the grantor fail to keep any of the foregoing covenants, then the efficiary may at its option carry out the same, and all its expenditures thereficiary may at its option carry out the same, and all its expenditures thereshall draw interest at the rate specified in the note, shall be repayable by
