

ASSIGNMENT OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, That the undersigned Vendee by recorded assignment for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto Alme L. Ailshire, Daniel Stephens and Marjorie Ralph

his heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated July 11, 1973, between M. M. Howell and Verda R. Howell, husband and wife as seller and Alme L. Ailshire, Daniel Stephens and Marjorie Ralph

as buyer, which contract is recorded in the Deed* Miscellaneous* Records of Klamath County, Oregon, in book M73 at page 9055 thereof, or as file number (indicate which), (reference to said recorded contract hereby being expressly made), together with all of the right, title and interest of the undersigned in and to the real estate described therein; the undersigned hereby expressly covenants with and warrants to the assignee above named that the undersigned is the owner of the vendee's interest in the real estate described in said contract of sale and that the unpaid balance of the purchase price thereof is not more than \$ 8,365.89 with interest paid thereon to June 6, 1977; further, upon compliance by said assignee with the terms of said contract, the undersigned directs that conveyance of said real estate be made and delivered to the order of said assignee.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 5,000.00. However, the actual consideration consists of or includes other property or value given or promised which is part of the consideration (indicate which).

In construing this assignment, it is understood that if the context so requires, the singular shall be taken to mean and include the plural, the masculine shall include the feminine and the neuter and that generally all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to one or more individuals and/or corporations.
