

KNOW ALL MEN BY THESE PRESENTS, That GLORIA A. COMFORT

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by KLAMATH COUNTY, a political subdivision, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning on the West line of Lot A of SUBDIVISION OF ENTERPRISE TRACT NO. 24, 75 feet South of the Northwest corner of said Lot A; thence South 75 feet; thence East 299.5 feet; thence North 75 feet; thence West 299.5 feet to the point of beginning, Klamath County, Oregon.

SUBJECT TO: (1) Taxes for the year 1977-78 due but not yet payable. (2) Regulations, including levies, assessments, water and irrigation rights and easements for ditches and canals, of Klamath Irrigation District. (3) Regulations, including levies, liens, assessments, rights of way and easements of the South Suburban Sanitary District. (4) Reservations and restrictions, including the terms and provisions thereof, as set forth in Deed from E. M. Chilcote, et al., to Jess E. Smith, dated August 1, 1938, recorded August 2, 1938 in Deed Book 117 at page 97 to wit: "...subject to rights of way for irrigation and drainage ditches and canals, and subject to take water across lands for use of other lands."

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as set forth above

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 10,000.00
