proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
two springs

a tributary of Lake of the Woods
domestic use in Girl Scout Camp

for the purpose of

under Permit No. 32709 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
June 30, 1967
that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.04 cubic foot per second, being 0.02 c.f.s. from each spring

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 14, T. 37 S., R. 5 E., W. M.,
Upper-1640 feet North and 370 feet East; Lower-1640 feet North and 30 feet East;
both from the SW Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to _____ of one cubic foot per second
per acre,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right

established by the Water Policy Review Board.
