WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That JAMES N. BARNEY

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by CHARLES A. FISHER

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

The Southerly 48 feet of Lot 18 and the Northern 14.1 feet of Lot 19 in Block 3 of SHADOW HILLS No. 1, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Reservations and restrictions in the dedication and on the plat of Tract No. 1031 Shadow Hills Subdivision No. 1.
2. Regulations of Enterprise Irrigation District.
3. Restrictions as shown on recorded plat of Shadow Hills No. 1.
4. Utility easements as delineated on the recorded plat along the rear 8 feet of subject property.
5. Easement created by instrument recorded December 21, 1962 in Book 342, page 155, Deed Records of Klamath County, Oregon.
6. Trust Deed in favor of First Federal Savings and Loan Association of Klamath Falls, Oregon, recorded in Volume M73, page 14816, which the grantee herein agrees to assume and pay.
