BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That E. Tharalson, a widower and Lane Duncan, an unmarried man, each to an undivided 1/2 interest, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Joseph R. Lussier, an unmarried man and Jeanette Baxley, an unmarried woman, not as tenants in common but as joint tenants with right of survivorship, and unto grantees' heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

SE 1/4 of Section 36, Township 35 South, Range 11 East, Willamette Meridian.
160 acres more or less as per government survey.

SUBJECT TO: Reservations, restrictions, rights, rights of way and easements, if any, apparent on the ground and of record in Official Records of said County.

To Have and to Hold the same unto the said grantees and grantees' heirs, successors and assigns forever.
