

ASSIGNMENT OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto WILLIAM E. BRADLEY and MARGIE J. BRADLEY, husband and wife

his heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated May 1, 1973, between RIBELLE A. MORA, a single man as seller and ERNEST R. REYES, a single man and DIANA L. BROWN, a single woman

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 11,000.00

In construing this assignment, it is understood that if the context so requires, the singular shall be taken to mean and include the plural, the masculine shall include the feminine and the neuter and that generally all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to one or more individuals and/or corporations.
