 Township 37S, Range 15E W.M., Klamath County Oregon.

for the purpose of the monitoring, including observation and sampling, of
 an individual experimental subsurface or alternative sewage disposal system
 in or upon or appurtenant to the above-described property of Grantor by
 Grantee, its contractors, agents or employees.

Grantor, for himself and his heirs, successors and assigns, covenants
 and agrees with Grantee, and its successors and assigns, that the above-
 described property of Grantor shall not be used for any purpose detrimental
 to said sewage disposal system and the monitoring thereof or contrary to the

laws and rules of governmental agencies applicable or related to such sewage disposal system.

Grantor warrants that he has full legal right to grant this easement.

This easement shall terminate on June 30, 1982 unless Grantee terminates this easement by giving written notice thereof to Grantor at an earlier date. Grantee shall be entitled to a one-year extension of this easement beyond the termination date stated above upon Grantee's written notification of Grantor prior to that date that Grantee elects to have such an extension of this easement.

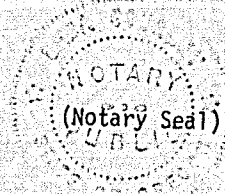
