wares and merchandise chooses in action and other property in possession or in action and to make due and transact all and every kind of business of whatever nature or kind whatsoever and also for her and in her name and act and deed to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, apothecations, bottomries, bills, bonds, notes, receipts, evidence of debts released and satisfaction of mortgages and judgments of other debts and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

Giving and granting unto this said attorney, full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully to all intents and purposes as she might or could do if personally present (with full power of substitution or revocation), hereby ratifying and confirming all that this said attorney (or her substitute or substitutes) shall lawfully do or cause to be done by virtue of these presents.
