KNOW ALL MEN BY THESE PRESENTS, That HAROLD L. JENSEN AND EILEEN C. JENSEN

FOSTER Husband and Wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 12 in Block 3, TRACT 1016, known as GREEN ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

1. Easements and restrictions as contained in plat dedication.
2. Conditions and restrictions as contained in instrument recorded in Vol. M70 page 6147.
3. Articles of Incorporation of Green Acres Improvement District.
