## QUITCLAIM DEED

**KNOW ALL MEN BY THESE PRESENTS,** That ERNEST O. KOEPKE and ELVA KOEPKE, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto CAROLINE O. MILNE, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot I, Block I, LONE PINE ON THE SPRAGUE, TOGETHER WITH AN UNDIVIDED 1/80 interest in and to the following, to-wit:

A tract of land situated in the SW1/4 of section II, and the NE1/4 of Section I4, all in T. 35 s., R. 9 E.M., Klamath County, Oregon, more particularly described as follows:

Beginning at an iron pin on the West line of the SW1/4 SE1/4 of said section II, said point being N. 0007'13" W. a distance of 71.79 feet from the South one-fourth corner of said Section II; thence S. 62o56'13" E. 572.55 feet; thence on the arc of a 130-foot radius curve to the right 24.17 feet; thence S. 52o17'05" E. 440.74 feet; thence on the arc of a 130-foot radius curve to the right 37.42 feet; thence S. 37o33'14" E. 141.09 feet; thence on the arc of a 130-foot radius curve to the right 71.41 feet; thence S. 06o04'53" E. 158.13 feet; thence on the arc of a 70-foot radius curve to the left 76.84 feet; thence S. 71o26'17" E. 279.26 feet; thence S. 72o03'57" E. 210.79 feet; thence on the arc of a 130-foot radius curve to the right 129.94 feet; thence S. 14o47'22" E. 269.56 feet; thence S. 30o E. to the intersection with the thread of centerline of Sprague River; thence Northwesterly along the thread of the Sprague River to its intersection with the West line of the SW1/4 SE1/4 of said Section II; thence S. 0007'13" E. along said West line to the point of beginning.
