WARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS, That Lawrence E. Plemons and Margaret I. Plemons, husband and wife hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Donald R. Workman & Cora E. Workman, husband & wife, & Buff Runnels & Darle Runnels, husband & wife hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

All that portion of Lots 3, 6, and 11 in Section 11 Township 36 South, Range 11 East, Willamette Meridian, lying Southerly of the boundaries of the Second Addition to Nimrod River Park as shown on the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, and lying North of the Sprague River.

Subject to easement reserved in Vol. M69, page 6117, Deed Records of Klamath County, Oregon.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances as of November 5, 1975;

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 4,792.00.
