KNOW ALL MEN BY THESE PRESENTS, That JOHN A. BENDER and MARGARET K. BENDER, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by JOHN G. MAGUIRE and BONNIE J. MAGUIRE, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

Lot 13, Block 2, FIRST ADDITION TO WINEMA GARDENS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Taxes for the fiscal year 1977-78, a lien but not yet due and payable.
2. Regulations of South Suburban Sanitary District.
3. Reservations and restrictions in deed recorded July 13, 1951 in Volume 248, page 397.
4. Building setback line 20 feet from street as shown on dedicated plat.
5. Utility easement as shown on dedicated plat.
6. Reservations as contained in plat dedication.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
