Klamath County. Title Company, an Oregon Corporation , as Trustee, and Fidelity Mortgage Company, Inc., A California Corporation , as Beneficiary, WITNESSETH:

Grantor irrevocably grants, bargains, sells and conveys to trustee in trust, with power of sale, the property in Klamath County, Oregon, described as:
