KNOW ALL MEN BY THESE PRESENTS, That WILLIAM S. THOMAS and SHIRLEY A. THOMAS, husband and wife, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by SUSAN K. WILCYNSKI, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

Lot 8 in Block 2 of MOYINA MANOR, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Taxes for the fiscal year 1977-78, a lien but not yet due and payable.
2. Regulations of South Suburban Sanitary District.
3. Reservations and restrictions as contained in plat dedication.
4. Building setback line 20 feet along streets, as shown on dedicated plat.
5. Public utilities easement along rear of each lot, as shown on dedicated plat.
6. Covenants, conditions and restrictions, imposed by instrument recorded September 4, 1968, in Volume M68, page 8013.
7. Mortgage in favor of the State of Oregon, represented and acting by the Director of Veterans Affairs, recorded October 18, 1974 in Volume M74, page 13666, which the grantee herein agrees to assume and pay according to the terms contained therein.

and that

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 45,500.00.
