Beginning at a point 410 feet West and 215 feet North of the SE Corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 25, Township 24 South, Range 8 E.W.M.; thence Northparallel with the East line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 225 feet thence West parallel with the North line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 30 feet thence South parallel with the East line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 225 feet thence EAST PARALLEL with the South line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 30 feet to the point of beginning.
