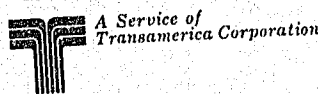

PARCEL 1: Beginning at a point on the north line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 25, Township 38 South, Range 8 East Willamette Meridian which is 275 feet west along the north line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 25 T. 38 S., R. 8 E.W.M. from its intersection with the southerly boundary of the Rock Creek Road; thence east 125 feet along the north line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the said Section 25; thence northerly and easterly in a straight line to a point on the southerly boundary of the Rock Creek Road which is 150 feet northerly and westerly from its intersection with the said North line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the said Section 25; thence Northerly and westerly along the southerly boundary of the Rock Creek Road 125 feet; thence southerly and westerly in a straight line to the point of beginning, all a part of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 25, Township 38 South, Range 8 East of the Willamette Meridian.
