The grantee, and the agents and employees of the grantee, shall have the privilege of entering upon said premises for the purpose of making necessary repairs to or changes to said sewer.
The said sewer shall be placed underground in the purpose of changes to said sewer.

The said sewer shall be placed underground in the usual manner and grantee agrees to replace the surface of the ground above the sewer in substantially its present condition and repair or surface of said ground except during the period of sewer construction and during the period of any following such repairs.
