KNOW ALL MEN BY THESE PRESENT, that FLYING DUTCHMEN LAND & CATTLE CO., INC. an Oregon Corporation, an estate in fee simple hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by ELSO DeJONG, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

ALL those lands situated in Sections 15 and 22 twp. 39 S.R. 11 E.W.M., Klamath County, Oregon, being more particularly described as follows:

Section 22: NW $\frac{1}{4}$; NE $\frac{1}{4}$ SW $\frac{1}{4}$
Section 15: S $\frac{1}{2}$ SW $\frac{1}{4}$

ALSO: That tract of land described as follows: Beginning at a $\frac{1}{2}$ inch iron pin from which the northwest corner of said Section 15 Bears N 01° 44' 03" W 3681.45 feet; thence S 78° 02' 07" E 174.45 feet to a $\frac{1}{2}$ inch iron pin; thence S 89° 52' 45" E 231.30 feet to a $\frac{1}{2}$ inch iron pin; thence S 89° 20' 52" E 801.00 feet to a $\frac{1}{2}$ inch iron pin; thence S 15° 16' 07" E 217.00 feet to a $\frac{1}{2}$ inch iron pin; thence continuing S 15° 16' 07" E 20 feet, more or less, to the south line of the N $\frac{1}{2}$ SW $\frac{1}{4}$ of said section 15; thence Westerly along said line to the southwest corner of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 15; thence Northerly along the west line of said Section 15 to a point that bears S 81° 00' 05" W from the point of beginning; thence N 81° 00' 05" E to a $\frac{1}{2}$ inch iron pin set in an existing north-south fence line; thence continuing N 81° 00' 05" E 76.21 feet to the point of beginning, containing 7.2 acres, more or less, with bearing based on Borne Addition to the Town of Bonanza; TOGETHER WITH: an easement 20 feet in width, the center line of which runs from the above described point of beginning N 13° 12' 00" W 335 feet to an existing pump for irrigation purposes.




