excepted; to pay all costs of planting, caring for and harvesting the crops raised upon the leased land. LESSEE further agrees to save LESSORS harmless from any and all liability as a result of spraying, irrigating, farming or operating said land during the term of this lease; and not to assign this lease nor sublet the premises without first securing the written consent of the LESSORS.

It is agreed between the parties hereto that LESSORS shall have the right to pasture any alfalfa presently planted on the above parcels of land, and to retain all sums he may ceive as pasture rent for the same, during the fall of 1977.

LESSEE agrees that at the time this lease is terminated and the property returned to LESSORS at least one-half (4) of the property will be seeded in grain or alfalfa, so that the condition of the property is the same as, or very similar, to the present condition of the property.

LESSEE further agrees that certain major ditches, to be shown to the LESSEE by the LESSORS, shall be left upon the land, shall be maintained by the LESSEE, and shall be in good condition when this lease is terminated and the property returned to the LESSORS.

The provisions and conditions of this lease shall be binding upon the parties and inure to the benefit of the heirs, executors, administrators, successors and assigns of the parties hereto.
