KNOW ALL MEN BY THESE PRESENTS, That WILLIAM W. KEYT and JUNE L. KEYT, husband and wife, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by O. D. GASTON and IVA GASTON, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Township 40 South, Range 12 East of the Willamette Meridian

Section 20: S $\frac{1}{2}$ of NW $\frac{1}{4}$, SW $\frac{1}{4}$ of NE $\frac{1}{4}$, S $\frac{1}{2}$ except the NE $\frac{1}{4}$ of SE $\frac{1}{4}$

Section 28: NW $\frac{1}{4}$ of NW $\frac{1}{4}$

Section 29: NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, N $\frac{1}{2}$ of NE $\frac{1}{4}$, SE $\frac{1}{4}$ of NE $\frac{1}{4}$, NE $\frac{1}{4}$ of SE $\frac{1}{4}$, except South 1030 feet, ALSO except that portion conveyed to Shasta View Irrigation District

Section 30: NE $\frac{1}{4}$, N $\frac{1}{2}$ of SE $\frac{1}{4}$, NE $\frac{1}{4}$ of NW $\frac{1}{4}$, N $\frac{1}{2}$ of SE $\frac{1}{4}$ of NW $\frac{1}{4}$, Lot 1 and N $\frac{1}{2}$ of Lot 2

Township 40 South, Range 11 East of the Willamette Meridian

Section 24: S $\frac{1}{2}$ of NE $\frac{1}{4}$, N $\frac{1}{2}$ of N $\frac{1}{2}$ of SE $\frac{1}{4}$, all lying East of the Malin-Bonanza Road

 And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except those of record and appurtenant upon the land

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
