## SHERIFF'S DEED

## WITNESSETH:

WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamath County, Oregon, between PACIFIC WEST MORT-GAGE CO., an Oregon corporation, plaintiff, and COUNSELORS CAPITAL CORPORATION, an Oregon corporation; DOUGLAS COUNTY TITLE COMPANY, an Oregon corporation; GEORGE F. COUNSIL and JEANNETTE K. COUNSIL, husband and wife; WILLAMETTE VALLEY TITLE CO., an Oregon corporation; DWAINE O. DIEKMAN and WINIFRED DIEKMAN, defendants, a judgment and decree was entered on September 11, 1976, for the foreclosure of a mortgage on the real property described below; and
