A tract of land situated in Sections 10 and 11, T.35 S., R.11 E., of the W.M.,
 in the County of Klamath and State of Oregon described as follows:

Beginning at the most Northerly corner of Lot 2, Block 28 of OREGON PINES, a
 duly recorded plat; thence North 65° 33'29" West a distance of 382.00 feet; thence
 North 24° 33'49" East a distance of 947.98 feet to the most Southerly corner
 of a tract of land described in a Contract to Dr. Ben McGough, recorded October
 27, 1977 in Volume M-77, Page 20598, Deed Records; thence North 77° 59'09" West
 along the Southerly line of said Dr. McGough tract a distance of 1189.55 feet
 to an intersection with the centerline of an existing Indian Service Road;
 thence along said centerline on a non-tangent curve to the right, having a radius
 of 1600.00 feet and a central angle of 12° 25'40" (the radial point bearing
 North 77° 59'09" West), a distance of 347.05 feet; thence continuing along said
 centerline South 24° 26'31" West a distance of 956.13 feet to an angle corner in
 the boundary line of a tract of land described in a Contract to Larry D.
