SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS (INDIVIDUAL)

NE 1/4 NE 1/4 of Section 5 Township 36 South, Range 11 East of the Willamette Meridian, Excepting therefrom the W 1/2 NW 1/4 NE 1/4 and also excepting the E 1/2 SE 1/4 NE 1/4 NE 1/4

TOGETHER WITH the rents, issues and profits thereof, SUBJECT, HOWEVER, to the right, power and authority given to and conferred upon Beneficiary by paragraph (10) of the provisions incorporated herein by reference to collect and apply such rents, issues and profits.

For the Purpose of Securing: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. 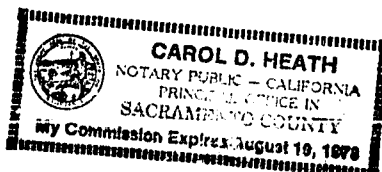
