KNOW ALL MEN BY THESE PRESENTS That G. P. Peyton & Doris A. Peyton as tenants in the entirety and Lowell R. Sharp & Mary Jo Sharp as tenants in the entirety,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Jack R. Roberts and Karin W. Roberts, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the said grantees and grantees' heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 12, Block 8 ELDORADO ADDITION to the City of Klamath Falls, Oregon according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Also that portion of vacated Peach Street adjacent thereto as described in Vacation, dated November 6, 1968, recorded November 6, 1969 in Volume M69, Page 9356, Microfilm records of Klamath County, Oregon.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
