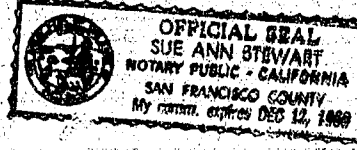
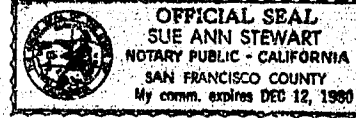

The above parcel contains 0.0592 acre.

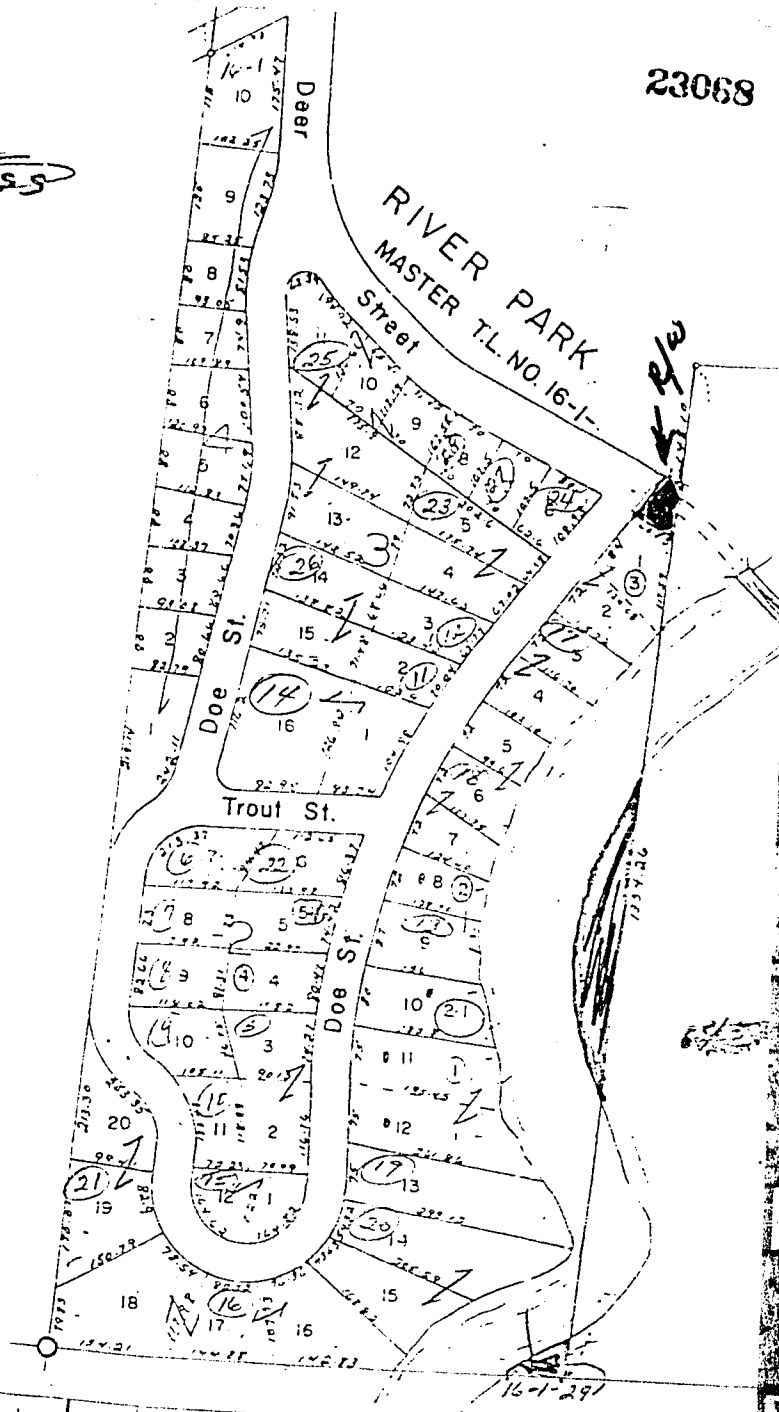
